6. Non-Material Amendment(s) Sought

The proposal reduces the height of the sliding doors on the rear elevation by 300mm to 3000mm tall. This is due to manufacturing constraints. Mullions are added to 2no. windows facing Underhill Street for the same reason - the manufacturer can't guarantee a window over 3000mm in length (without any mullions). The recess size will stay the same on this elevation.
