Sycamore T4 ( 22 metres high / 2 x 500mm co-dominant stems) - Remove 2 lowest limbs over lawn and reduce crown on house side by up to 3 metres

Sycamore T6 ( 25 metres high / 2 x 600mm co-dominant stems) - Remove lowest limb over lawn and reduce crown on house side by up to 3 metres

Sycamore T7 ( 16 metres high / 2 x 350mm co-dominant stems) - Remove lowest limb and reduce crown height by up to 3 metres

Sycamore T8( 16 metres high / 2 x 350mm co-dominant stems) - reduce crown height by up to 3 metres

Sycamore T9( 16 metres high / 2 x 300mm co-dominant stems) - Remove lowest limb and reduce crown height by up to 3 metres

## 7. Identification Of Tree(s) And Description Of Works

Sycamore T11( 16 metres high / 250mm stem) - pollard at 8 metres

Pine T10 - dead - fell to ground level

Reasons:

1. T4 and T6 causing excessive shading to new lawn area
2. T7 to T11 have been severely affected by soil level increase over root zone and die back has occurred - situation has now been remedied by soil removal back down to original levels
