Reduce height by 1.8 mtrs, reduce material branches by 600mm to bring into shape and to reduce the trees size to allow more light into back garden. as advised, i am applying to cut less than original application due to the root trauma the tree will have suffered in a recent landscape build.

T2- Crab apple. a new TPO has been issued on this tree so new application is to prune by thinning out the tree to allow the tree to develop better. to reshape the tree by reducing the height by 500mm and lateral branches by 500mm

T3- magnolia, front garden. tree to be removed to ground level and stump removed. tree has got to big for small front garden space.
