<u>Details to Discharge of Conditions 6 & 8 attached to 2015/0851/P at 2 Akendside Road, London</u> Cover Note

Planning Permission for the 'Excavation of basement level and erection of a single storey rear extension. Conversion of garage for use as habitable residential space and other associated alterations' at 2 Akenside Road, London was approved on the 12th September 2016.

Condition 8

Condition 8 requires the following:

"The development hereby approved shall not commence until such time as a suitably qualified chartered engineer with membership of the appropriate professional body has been appointed to inspect, approve and monitor the critical elements of both permanent and temporary basement construction works through out their duration to ensure compliance with the design which has been checked and approved by a building control body. Details of the appointment and the appointee's responsibilities shall be submitted to and approved in writing by the local planning authority prior to the commencement of development. Any subsequent changes or reappointment shall be confirmed forthwith for the duration of the construction works"
