- Crown lift to allow 3m clearance from ground level.
- Crown reduce height by 4m and shape all sides to match.

T2) London plane (platanus x hispanica):

- Crown reduce height by 6m.
- Reduce on road side by 2.5m
- Crown reduce all sides to match.
- Retain a final height of 11m

T3) London Plane (platanus x hispanica) (neighbouring tree):

- Prune back all overhang to boundary line, using rigging equipment to lower all overhanging branches.

T4) London Plane (platanus x hispanica) (central tree):

- Aerial inspect upper crown for Massaria disease of Plane. (prune massaria infected branches as necessary)
- Remove weight from heavy lateral branches.
- Remove all dead, crossing, weak and suppressed branches.

T5) Magnolia:

- Formative prune.

T6) London plane (platanus x hispanica) (corner of entrance gate):

- Remove epicormic growth.

G1) Row of hornbeams:

- Retain laterals and prune all other sides to shape, including height.

G2) Ivy on boundary wall:

- Trim back hard
