T1-Bay(Laurus nobilus)
-reduce and lift crown by 30% to contain height and spread

T2-Tulip Tree(Liriodendron tulipifera)
-formative prune by 25%(1.5m)
-reduce sides to match, shape to balance and tidy

T3-Lime(Tilia cordata)-tight target w/glass greenhouse+pagoda -reduce height by 25%(3m)
-reduce sides to match

T4-Cypress(Cupressus)
- cut back and shape lower crown only

7. Identification Of Tree(s) And Description Of Works

T5-Holm Oak(*Quercus ilex*)
-reduce to previous cuts(1.5m)
-lift canopy by 2m, shape to balance and tidy

T6-Whitebeam(*Sorbus aria*)
-reduce crown to previous points
-cut back spread to allow 1.5m separation from both property -remove all deadwood and shape to balance

ALL tree work for regular maintenance
