- Thin crown to remove approximately 20% of live branches to improve light and air penetration through crown. Most thinning cuts will be between 2 and 3 centimetres in diameter.

Prune Fig located at the back of property according to the following specifications:

- Reduce crown height and spread by approximately 2-3 metres to enhance natural form.

Prune the following property items:

- Apple located at the rear of house

- Clean, thin and reduce crown as necessary to promote fruit production and quality. Fruit tree pruning will reduce the risk of branch failure due to excessive fruit production
