The current use of restaurant begun as far back as 1991 (prior to St Charles ownership). The lease was terminated in 1998 by tenant bankruptcy. In 1998, the tenant (A.K.Toor) traded as "Favourite Chicken". And assigned the lease to S Mirza Baig on January 4th 2001. The restaurant name was changed to "Hen Cottage" 2003. The restaurant name was changed to "Fri-Chiks" 2008. The Lease forfeited in June 2016. The above states the few interruptions to the name of the restaurant from 1998 between tenants. Otherwise, it has been continuously trading as a A5 - hot food takeaway from 1998 until June 2016.
