On 1 September I sent you my objections to this application.

I enclosed my log of non-compliance with the Conditions attached to the S.106 Agreement relating to the existing illegal development of the undercroft at 67-74 Saffron Hill. My log covered the period 26 May – 31 August 2016.

I now enclose my log for September 2016, and in doing so, draw your attention to the following:

It is manifestly the case that Callprint cannot operate its business without a vehicle parking area. It does not have one and so continually uses the Service Yard in contravention of the Conditions of the S.106 Agreement. It also continually parks its vehicles illegally on Saffron Hill with utter contempt for amenity, the law, and safety.

In addition the Service Yard is used continually to store pallets, and continuously to store rubbish, and any other items which might be convenient for them, wholly contemptuous of the effect upon residents - who are of no importance.

It is difficult to see how this Landlord and this Tenant could have less concern for the Conditions attached to the S.106 Agreement, or for the interests and safety of residents.

I believe their behaviour disqualifies them in regard to the existing planning consent, which should be withdrawn, and it should also be sufficient for you to reject the current planning application 2016/3018/P.

The Council's primary priority in planning matters is to protect residential amenity. Saffron Hill is very narrow and congested, this site particularly so, with the result that it is operating unlawfully following the last illegal development, despite the Planning Inspector ordering its demolition.

The current application will add yet more space and consequently more people, noise, congestion, traffic, and parking on a narrow street which TfL will shortly be converting into a Cycle Super - Highway, adding further complexity to an already unsatisfactory situation.

I request that this Application be refused. Numerous previous applications, together with the Planning Inspector's Appeal Decision dated 12 January 2011 provide clear, unambiguous guidance.
