In 1987 planning permission was granted to erect a single story rear extension with two roof lights, each measuring internally 1.2m by 1.4m. This extension has been built, but currently has smaller roof lights installed (1.03m by 0.75m). We wish to replace these roof lights with new roof lights not larger than the original size indicated and permitted in the 1987 planning permission.

Following discussion with the duty planning officer (call reference ENQ/03201) on the 25th of July, where he measured the roof lights on the original plans to be 1.2m by 1.4m, I was advised to seek a certificate of lawfulness to revert the roof lights to these dimensions.
