Frank,

We can only fully discharge condition 9 upon a receipt of the verification report. However, it doesn't mean that the works cannot commence. The developer is not constrained by partial discharge of condition 9 and can commence works (providing all other pre-commencement planning conditions are fulfilled) as it would normally be expected that some level of works must start to facilitate the remediation.

Hope this clarification addresses your concerns.
