Nomination of Mansfield Bowling Club as an asset of community value under the Localism Act 2011

Thank you for your letter received on 15 May 2013. From the additional information you provided, it would appear that the contract does constitute an option to buy. However the Council would need to make a decision on exemption at the time of any proposed disposal (see below) and, as noted in my previous letter, the contract has no bearing on the decision to list the property as an asset of community value.

Please take this letter as notification that the entire Mansfield Bowling Club site has been listed as an Asset of Community Value as of 22 May 2013 (the date on the website will be amended accordingly). While it is the case the Council must inform the owner that it is considering listing the land, there is no requirement to consult with the owner although they do have the right to appeal against the decision (see below).

The consequences of listing for you as the owner of the land are as follows:

- Listing as an asset of community value would be considered as a factor in an application for change of use, as indeed is community opinion generally, but it would be considered alongside all the other circumstances of the individual case.
- You will need to inform the Council of your intention to dispose of the listed land. The
 Council would at that point consider whether the disposal is exempt and if so the six
 week interim moratorium period would not be triggered. In accordance with the
 legislation, the Council will make an entry on the local land charges register and
 enter a restriction on the land at the Land Registry.
- You have a right to appeal against the Council's decision to list the site as an asset of community value. The procedure for the review is set out in s92 of the Localism

Act and in Schedule 2 of the Regulations. The land would remain listed while the review is carried out. You have until 17 July 2013 to request an appeal.
