Garden of Flat B, 1 Ellerdale Road. Contact owner for access:

T1. Norway Maple- Reduce back to previous pruning positions, leaving plenty of buds and furnishing growth to facilitate a healthy recovery. This will involve taking up to 3m off the height and up to 2m off all side growths. Give 2m clearance to the house and clear the street light.

T2. Small Plum Tree- Lift to statutory height over pavement and lightly reduce/ reshape to give a more compact crown.
