We weren't allowed to make a formal noise complaint because noise complaints against the Council are not permitted..... We were advised to fit secondary glazing, which we did at enormous expense.</p> <p>Current Situation</p> <p>Our existing sliding windows work perfectly and it would be a gross extravagance to replace them! I understand that other flats also have secondary glazing and I believe that other leaseholders on the wider estate have successfully declined this "improvement".</p> <p>Our windows are absolutely fine. I don't know about the rest of the block but on the face of it I can't see why this part of the Council can get away with spending a lot of money on this when other parts are being squeezed dry.</p> <p>Planning Observation</p> <p>The proposed Type F windows are different from the actual, which have 4 full height panes only. Presumably proposed balcony doors open inwards.</p> <p>I can't understand why planning permission is being sought for something that hasn't been approved subject to the formal major works consultation process.</p> <p>Casement windows are not compatible with our, and others, expensive secondary glazing. If it is absolutely necessary to replace some windows then hopefully a sympathetic design, readily available, will be used in order to maintain the aesthetic integrity of the buildings.</p> <p>I guess aesthetics is the only real planning issue... in which case the predictable unaesthetic mix of casement and sliding windows are clear grounds for rejection. The replacement casement window façade higher up Millman Street looks like an advent calendar on 12th December for much of the time – an unpleasant contrast with the smooth design of the existing.</p> <p>Bill Murray Flat 7 Millman Place</p>
