E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

Group of Elder and Ash: Located rear of pool area overhanging from rear land strip. Reduce overhang back from pool area by approximately 30% to control encroachment and help abate nuisance.

Pear: Located rear path between courtyard and pool area. The top section of this tree has now died completely. The lower section remains vigorous. Remove upper dead section of the tree.

Mimosa: Located in courtyard area. It was noted that some lower branches of these trees which overhang Thurlow Court have been cut back. This has unfortunately compromised lower screen somewhat. There has also been some foliage loss over the past few years. Remove dead wood only throughout crowns to help reduce potential hazards.

Large Ash: TPO. Overhanging from Thurlow Court. Reduce overhanging lateral and sub lateral branches by approximately 1.50m-2.00m back to previous reduction points whilst preserving a suitable amount of furnishing growth to ensure crown continuity and preserve aesthetic value.

Large Ash: Located in central lawn area. Reduce crown by approximately 25-30% and thin crown density by 20-25% as general maintenance.

Dead Pyracantha: Located on Cottage Access Path. Fell to ground level.

Large Multit-Stemmed Dying Pyracantha: Reduce to approximately 6.00-8.00m in height. Ivy to be retained for screen.

7. Identification Of Tree(s) And Description Of Works

Leaning Conifer: Reduce crown by 30% in order to reduce as much weight as possible due to heavy lean.

Row of Leyland Cypress: Located behind pool house. Reduce height back to previous reduction points, approximately 1.50m, to control height whilst preserving screen.
