- New roof extension & roof top plant





#### 2.1 Site Location

The site is located on the eastern side of Red Lion Street at the corner of Sandland Street, in the heart of London's Midtown. Red Lion Street links High Holborn to the south with Theobald's Road to the north. High Holborn is a major arterial route through Midtown, connecting it with the City and West End.

Midtown has been London legal's centre for many centuries and remains a popular destination for many legal occupiers, due to the proximity of the Royal Courts of Justice, Old Bailey and Inns Court.



2.2 Site Location Plan









