We request that the noise emission limits noted in the Acoustic Report 11/1450/R1 dated 12/05/2011 and noted under clauses 3.2.2, 3.2.3 and 3.2.4 of that report are those that should be used to indicate compliance with the correct requirements of planning consent 2012/2209/P Condition 2. This report set out an approach in respect of generator noise that does not appear to have been correctly interpreted in the wording of Condition 2 of the consent.

This is set out in explanatory memo by Cole Jarman , reference 16/0216/M1 dated 22 April 2016.

If you wish the existing condition to be changed, please state how you wish the condition to be varied:

We request that the wording of Condition 2 is varied in accordance with Cole Jarman's memo , reference 16/0216/M1 dated 22 April 2016, which set out the approach in respect of generator noise under clause 3.2.3 and is worded as follows:

Noise emitted from the emergency plant and generators hereby permitted shall not increase the minimum assessed background noise level (expressed as the lowest 24 hour LA90) by more than 10 dB one metre outside any premises.

The emergency plant and generators hereby permitted may be operated only for essential testing, except when required by an emergency loss of power.

Testing of emergency plant and generators hereby permitted may be carried out only for up to one hour in a calendar month, and only during the hours 09.00 to 17.00 hrs Monday to Friday and not at all on public holidays.
