The proposal is for a complete refurbishment of the ground and basement floors. Ground floor works include a completely new shopfront with retractable enclosed seating. The opening up of the stairwell to create a greater sense of openness. The fabrication of a new smaller bar area and increased banquet seating area to the rear. Works to the basement floor include a reduction to the kitchen area to allow for new patron sanitary provisions. Part of the circulation space to the rear will be converted into a private dining area with separate patron sanitary provisions. Storage space will be increased by knocking through into the basement space 46 Eversholt Street (this building is owned by Mr Birendra Manandhar).
