Erection of a rear dormer to existing single family dwelling

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 The development hereby permitted shall be carried out in accordance with the following approved plans; Site location plan; N24 - (2/8, 3/8, 4/8Rev1, 5/8Rev1,



6/8, 7/8, 8/8Rev1)

Reason: For the avoidance of doubt and in the interest of proper planning.

- 3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

Informative(s):

- 1 Reasons for granting permission.

The proposed rear dormer window is considered acceptable in terms of size, form and design. This is due to its modest size where it is set in from the eaves and ridge of the roof. It relates to the window proportions below and would sit comfortably within the existing roof and reflects the varied roof form within the surrounding area.

The materials would match the main property and would be in keeping with the character of the area. Therefore the proposal is considered to preserve the character and appearance of the Parkhill Conservation Area.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

The proposed rear dormer would not harm the neighbouring amenity in terms of overlooking or loss of light.

The Parkhill Conservation Area Advisory Committee raised no objection to the proposal. The site's planning history and appeal decisions were taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24, DP25 and DP26 of the London Borough of Camden Local Development Framework Policies. The proposed development also accords with The London Plan 2016 and the National Planning Policy Framework


