T3: Eucalyptus: Approximately 15.00m. Remove dead wood only.

S1: Hazel: Approximately 4.00m. Reduce crown by 30% to form a more compact crown.

T4: Hawthorn: Approximately 6.00m. Formative prune by thinning crown density by 25% and reduce crown by 15-20%.

T5: Pittosporum: Reduce crown by 20%.

G1: Yew Hedge: Approximately 6.00-7.00m. Reduce height by approximately 1.00m to encourage lower re-generation of centre hedge.

S2: Privet: Trim height by approximately 15cm.

T6: Small Yew. Approximately 5.00m. Trim height by 20% to tidy.

G2: Yew Hedge Group: Approximately 7.00m. Trim to tidy by approximately 15-30m.

7. Identification Of Tree(s) And Description Of Works

T7: Hornbeam: Located adjacent house. Approximately 17.00m. Raise crown over rear boundary hedge by 1.00-1.50m. Reduce back lateral growth to clear building by 0.50 to 1.00m.

Front Garden:

G3: Beech Hedge: Prune back into main hedge structure forming arch.
