Front Garden:

Lime: Reduce crown back to previous reduction points whilst retaining an appropriate amount of furnishing growth in order to maintain crown continuity. Remove one low limb growing over the road and footpath, (approximately 13cm diameter at branch stem union). Raise crown by 1.50-2.00m. Reasons: To increase light levels, help maintain the tree at reasonable dimensions for its location and help abate nuisance whilst preserving the tree's natural characteristics and aesthetic value.
