(NO CHANGE OF USE) This is for the re-establishment of an existing rear roof terrace which serves as outdoor space for Flat 2 and is the roof the kitchen below for this unit. The current access is off of the stairwell landing towards the next level with a one over one double hung window that needs to be replaced with a new one and we wish to change it to a 2 pane French door unit for safer egress. The roof itself requires an additional structural floor to accommodate live loads for terrace usage. The balcony ledge needs to be extended with a painted steel safety railing which is to be no less than 1200mm from the finished floor. We would also like to reference the same condition at the next door neighboring property at 22 Croftdown road which we aim to replicate 100% in order to bring it up to code and satisfy the architectural character.
