T1 oak Front Mature, widespreading tree. The tree overhangs the road and has been struck by a high sided vehicle. This caused the branch to fail and fall on a passerby. To prevent this from happening again, the suggested works are: To reduce the overall height and the lateral spread all round by 2 - 2.5m, ensure statutory heights over the road and footpath (2.5m and 5m), clean out crown, remove deadwood.
