Structural repairs to internal spine walls at third and second floor storey levels by insertion of new steel beams and columns within existing floors and walls. Replastering of internal partitions where structural repairs are required. Replacement of failed steel framed rooflights with timber framed rooflights. Removal of 1950s timber door structure providing external roof access. Replacement of asphalt roof guttering with lead work. Replacement of failed cement render to chimney stack masonry with lime render. Redecoration of existing timber window frames to front facade.
