Laurus nobilis planted on the south side of the house in the side passage: we would like to raise the canopy to fence height level and round the top to bring height down to mid point between ground floor and first floor windows. The tree is too big and is causing excessive shading inside the house and there are also access issues along the side passage of the house.
