Proposal:

WITHIN GROUNDS: 1 x Lime - Remove ivy & lift to 6m

- 1 x Scarlet Oak Lift to 5m, reduce 2 x 3 inch diameter branches at top towards east by 50%
- 1 x Sycamore Remove 3 branches overhanging new house garden
- 1 x Blue Cedar Reduce 3 broken branches over light, over drive and over lawn by 3m
- 1 x Hollow Oak Reduce overall by 15%

The Council has considered your application dated 10 July 2016 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Council to monitor the completion and standards of the work.



2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
