I have submitted an objection, but would like to add the following about the Asset of Community Value:

Our Mansfield Neighbours group & Dartmouth Park Area Advisory Committee put in the bid to have the Mansfield Bowling Club listed as an ACV. This is because the tennis club is going strong, despite the intentional neglect of the rest of the site, and local children still use the car park for practicing learning to ride their bikes, and the Bowling club building until recently had an active bowling community there.

So the site was listed.

In Spring 2016, not the Bowling Club but their property developers, Generator informed the Council that the property was on the market. I have attached email communication between me and the most active director of the Mansfield Bowling Club. It shows that he doesn't take the ACV process seriously, they haven't appointed an estate agent or are prepared to define what is for sale. As a community group we have spend hours calling around the local sports clubs, sports providers and soft play areas, doing far more work than the Bowling club in ascertaining local sporting need. We have many interested parties who would like to use the venue or take on the site to run it, but in being directed to the Bowling club, have been knocked back, told that 'we will win the appeal and will build houses, so the site is too expensive for you'. (You will have received an objection from Amy Silverstone, will all these details laid out in it)

My role has been to try and sit round the table with just the Bowling club directors, to try and persuade them to genuinely engage with the local community, if they set their financial sights a bit lower then they would have our wholehearted support in helping create a profitable long term sporting facility. But I have been disappointed in that they are unprepared to meet us in a friendly open manner.

I believe that they triggered the ACV in the mistaken belief that by letting us all pitch our proposals, they would wait out the moratorium and then remove the ACV. Our advice from Camden Coucnil is that you can't just remove an ACV listing, the site is no different now than when it was listed.
