T2 Acer pseudoplatanus (Sycamore) - Good: Pruned by SHT fifteen years ago, takes light, overhangs neighbour's house, ivy - Raise crown to 10m, crown thin by 25-30%, remove ivy, prune back to boundary, reduce height by 5m.
