Rear Garden:
T1: Magnolia: Tree appears stable and in reasonable health considering previous canker. Trim back extraneous rose growth into main crown structure. Remove dead wood as is practicable.
T2: Birch: Reduce lateral and sub-lateral branches by approximately 15% and thin crown density by 20%.
T3: Birch: Located closest to house. Reduce crown by 20% and thin crown density by 20%.
G1: Magnolia Grandiflora Row. Reduce overhang back from lawn by 20% Reduce lateral and sub-lateral branches growing over neighbouring property to the rear by approximately 20% to control encroachment whilst preserving screen.
T4: Small Bay: Reduce crown back to previous points to tidy.
T5:Bay: Reduce crown by 20% back to previous.
G2: Jasmine: Growing adjacent house wall. Trim to tidy and control encroachment into gardens.
S1: Griselinia: Trim hard back to tidy and keep separated from bay.
T6 Bay: Located on fence line boundary. Fell to ground level.
