01 - Side extension amended to have two absurd windows to bathrooms behind at level 2 and level 3. Currently the bathroom on level two does not have a window. The proposal is to bring natural light into the bathroom. Currently on Level 3 the bathroom has a roof light - which the proposed extension will cover - the proposal is to bring natural light through a wall window.

02 - Side extension amended to have drainage pipes. Currently - drainage is routed through the building, which causes issues with leaking and maintenance. The proposal is to bring drainage external of the building to mitigate risk of leaks within the property and for ease of access for maintenance.
