The first part of the proposal is to extend 90 Torriano Avenue, First and Second Floor Flat on the roof of the ground floor flat to make it inline with 92 Torriano Avenue building on the front façade. This extension will match the existing style and material. The second part of the proposal is to create a new loft space on the roof of 90 Torriano Avenue. With these changes, there will be enough sqm to divide the new layout into two flats. The first flat will occupy the first floor with one bedroom, bathroom and a living room. The second flat will occupy the second floor with a bedroom, a bathroom and a livingroom, and the loft space with a kitchen, a bedroom, and a bathroom. This proposal will increase the site area from 97.72sqm to 136.7sqm. Existing windows of the flat are all rotten. We propose to change these windows with new ones matching the existing.
