T1. Yew Tree in garden of 118 Heath Street (TPO tree, see reasons for work below)- Reduce by up to 1m all round, preserving the general shape and giving up to 1m clearance from nearby building.

T2. Purple Plum in forecourt of 120 Heath Street- Reduce height by to 2m.
- Reduce side growths by up to 1m to give good clearance to nearby buildings.
- Remove growths at base of tree.
- Remove 1 low limb (diameter 3cm) at 2m.

Reasons for work- To prevent excessive branch extension over Hampstead Square and possible branch tearing.

- To minimise excessive berry dropping. The berries drop onto the pavement by the Quaker Meeting House, making it slippery. Many children use this path and entranceway.
- Reshape to maintain the health of the tree.

- Reduce 1m all round to clear the property/building of no. 118.
