SIDE GARDEN: 1 x Apple T1 - reduce back towards previous pruning positions, leaving plenty of buds and furnishing growth to facilitate a healthy recovery. remove dead, dying, and diseased wood. reshape crown to leave a natural outline. Up to 3m of regrowth to be removed only.

1 x Birch T2 - reduce back towards previous pruning positions, leaving plenty of buds and furnishing growth to facilitate a healthy recovery. remove dead, dying, and diseased wood. reshape crown to leave a natural outline. Up to 3m of regrowth to be removed only.

1 x Birch T3 - reduce back towards previous pruning positions, leaving plenty of buds and furnishing growth to facilitate a healthy recovery. remove dead, dying, and diseased wood. reshape crown to leave a natural outline. Up to 3m of regrowth to be removed only.

REAR GARDEN: 1 x Ivy covered Pear T4 - reduce back overhanging growths and ivy.


The Council has considered your notification of intended works to trees dated 05 October 2016 and does not wish to object.
