Formal pre-application advice has not been sought but the principle of sub-division to create an additional dwelling was considered by withdrawn application 2013/3855/P. The officer's report stated that 'housing is regarded as a priority land use.....the proposed (additional) flat would assist the Council to meet the strategic housing target for the Borough..... In overall terms the principle of providing residential accommodation at this location is considered to be appropriate. The proposal is for a new 3 bedroom flat. Policy DP5 states there is a demand for 3 bedroom units. Overall, the creation of a new 3 bedroom dwelling and the alteration of the existing 3 bedroom flat at ground and basement level is considered acceptable.'
