T54 Lime: remove basal growth

T57 Portugal Laurel: crown lift to 2.5m from ground, prune 1.5m clear of building

T64 Elder: fell

T67 Prunus: remove lowest lateral branch over lawn, reduce further branches over lawn by 1-1.5m
