## Application to discharge Condition 3 'Detailed design and materials' pursuant to Listed Building Consent APP/X5210/E/13/2205521

On behalf of my client, University College London ("UCL"), please find enclosed an application to discharge Condition 3 'Detailed design and materials' pursuant to appeal decision APP/X5210/E/13/2205521.

Listed Building consent (reference 2013/0401/L) was granted on appeal (reference APP/X5210/E/13/2205521) on 8 April 2014 for:

"Internal alterations involving removal of the internal vestibule doors in the Flaxman Gallery and installation of new glass and bronze framed internal doors."

Condition 3 of the consent states:
