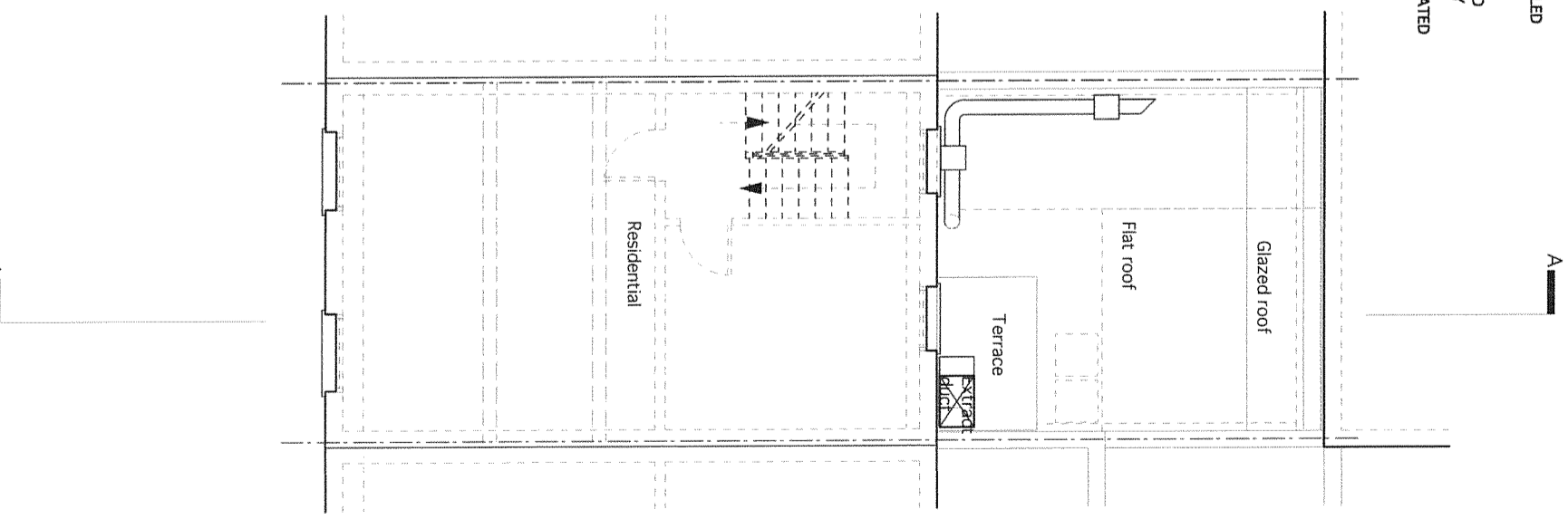
Basement plan



Ground floor plan

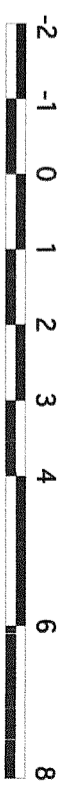


First floor plan

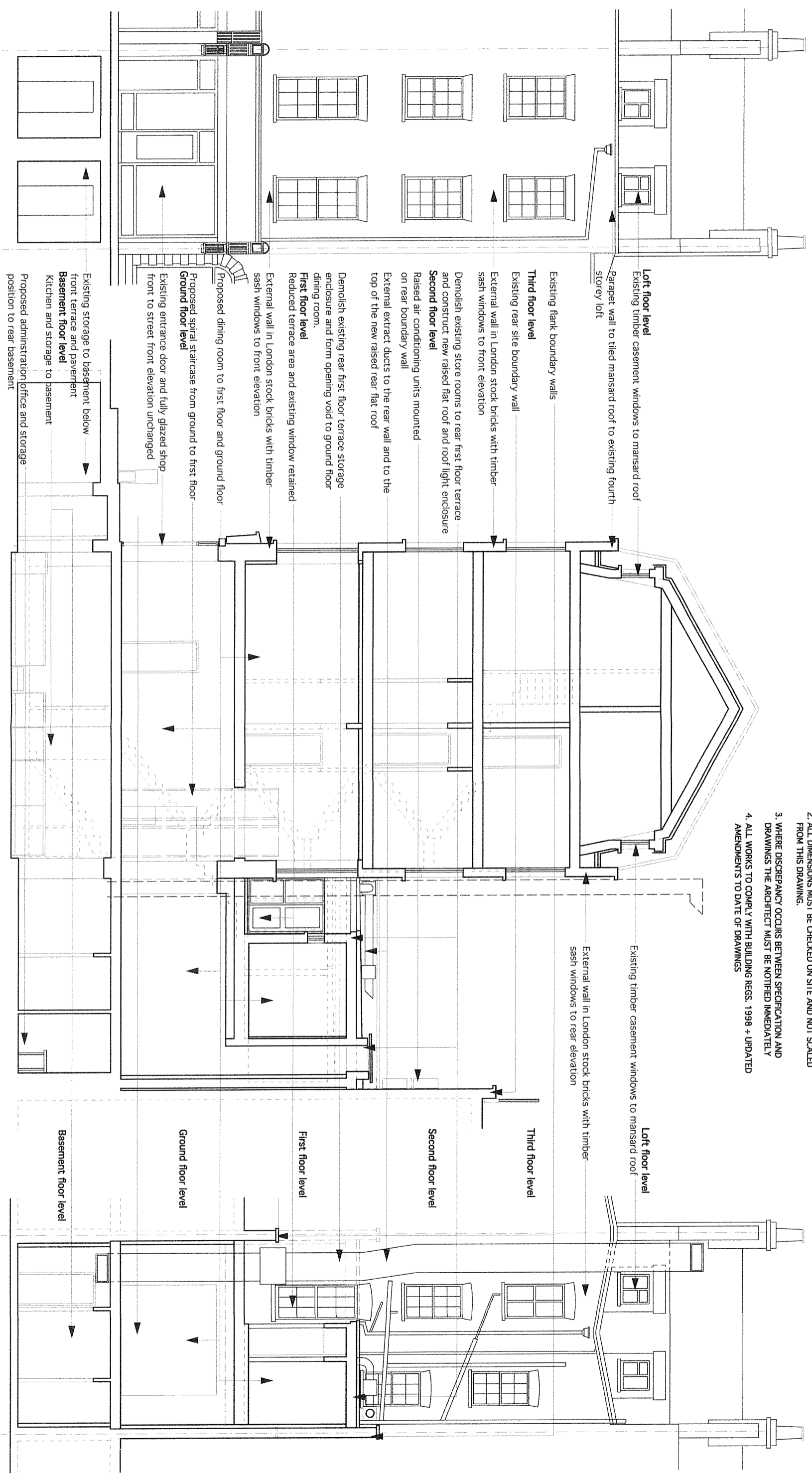
