		Terrace Camden London NW1 7RT	· ·	Over a period of years more and more structures have been constructed in this area, which is changing the character of the garden and the setting for the historic pub in a conservation area. The character of the garden should reflect the nature of the building and not obscure it.	
					The quality of this space, which forms a significant part of the setting of the Listed Building, has been allowed to erode gradually and allowing it to do so further is not acceptable in the Conservation Area.
					The proposal does not preserve or enhance the Conservation area and does not improve the setting - and therefore should be rejected.
					No further development should be permitted in the garden - had I been aware of the previous applications then these should have been challenged.
					As well as the character of the garden, I am concerned that there appears to be a desire to turn as much as possible of the garden into "internal" type space that can be used all year round with the associated increase of numbers of customers. This has had the impact of creating a venue with over 400 customers in the middle of a residential area. This size of establishment is inappropriate for a residential area and does cause nuisance.
					Over the summers as the volume of customers has risen there has been an ever increasing level of disturbance from noise during pub opening hours and especially at closing time. There have been issues of people remaining in the vicinity well after 11.30pm with a high level of noise and disturbance.
					This has been partially controlled by the presence of doormen but frequently they have only been present on a Thursday/Friday/Saturday night with considerable disturbance from earlier in the week in good weather. I am concerned that in the period the marquee is sought this disturbance will be repeated. Previously the presence of big screen TVs and amplification in the outside structures has also caused disturbance.
					Should permission for the marquees be granted, despite this and any other objections, I would request that a number of additional measures be introduced to control the disturbance on local residents.
