- T1 – 1 x Cedar to cut back from roof area.
- T2 – 1 x Oak – no action.
- T3 – 1 x Yew (Sparse) to crown lift to the approximate height of the roof.
- T4 – 1 x Leylandii to cut back off of patio area and to reduce in height to approximately 4 meters.
- G1 – Group of 5 Sycamore trees to pollard to previous points.
- T5 – 1 x Horse Chestnut to crown lift to approximately 4 meters and to cut back from building to give a minimum clearance of approximately 3 meters.
- G2 – Group of Holly to reduce in height to approximately 3 meters and to clip front face.
- G3 – Group of Sycamore Saplings to carefully dismantle to as close to ground level as possible.
- G4 – Group of Large Sycamores to remove Ivy and to crown lift to approximately 6 meters.
- T6 – 1 x Holly to crown reduce all around by approximately 1 meter.
- T7 – 1 x Yew to trim to reshape.
- T8 – 1 x Yew (very sparse) to crown lift to approximately 4 meters.

## 7. Identification Of Tree(s) And Description Of Works

- T9 – 1 x Leylandii belonging to neighbour to trim overlong branches over number 12 only.
- T10 – 1 x Purple leaved Norway maple to crown lift over roadside to approximately 3 meters and to crown reduce all around by approximately 2 meters.
- T11 – 1 x Cherry to crown reduce by approximately 2 meters.
- T12 – 1 x Purple leaved Norway Maple to crown reduce by approximately 2 meters.
- T13 – 1 x Norway Maple to cut back from building to give a minimum clearance of approximately 1 meter and to crown reduce the remainder by approximately 2 meters.
- T14 – 1 x Magnolia to crown lift over road side to approximately 3 meters and to cut back from building.
