T4 Mature London plane on northern perimeter adjacent to gardeners sheds with over extended crown to north into adjacent site

- Reduce low lateral limb above wall (at approx. 8m north) by approx. 3m back to the vicinity of the perimeter wall back to suitable secondary growth points
