I am writing to request a change of building usage classification from B1 to a dual usage of B1 and D1. The headquarters of CVCP at the address above is also the address of Woburn House Conference Centre Ltd which is located on the lower ground, ground, mezzanine and first floors of the building. The use of these areas are classed as non residential education and training centres (D1). The remaining parts of the 1st floor and floors 2, 3, 4, 5 and 6 are used as office space (B1). Therefore we are applying for a change to dual usage for the building from B1 to B1 and D1.
