Trees located in Rear Communal Garden and 2 trees located in front garden, Access is via flight of stairs in main hallway down basement area which leads to the garden.

T1 - Rear Garden- Large Acer, Crown reduce height by 1.5-2m, reduce laterals by 1.5-2m, pruning back to suitable growth points leaving shorten secondary growth to form a smaller, neater, symmetrical crown, Sever Ivy.

T2 - Rear Garden- Large Acer, ivy clad, Crown reduce height by 1.5-2m, reduce laterals by 1.5-2m, pruning back to suitable growth points leaving shorten secondary growth to form a smaller, neater, symmetrical crown,
Also shave off excess ivy back to within 8inches of main frame work.

T3 - Rear Garden- Medium Elder, fell as close as possible to ground level.

7. Identification Of Tree(s) And Description Of Works

T4 - Rear Garden- Small Shrub, shorten overall height and sides by 0.5m and reshape to form a neater specimen.

T5 - Rear Garden- Small Ash Sapling, Fell to ground level.

T6 - Rear Garden- Medium Elder on boundary line, Face back to boundary line to a height of 4m.

GRP1 - Rear Garden- Medium Self Set Ash, Elder, Sycamore and Saplins, fell to ground level.

GRP2 - Rear Garden- Medium Pyracantha, reduce regrowth to height of fence and face sides to form a box hedge.

GRP3 - Rear Garden- Medium Ivy on line fence, reduce height to fence height and face up sides.

T7 - Front Garden- Large Thorn, Crown reduce height by 1-1.5m, reduce laterals by 1.5-2m to form a smaller neater crown.

T8 - Front Garden- Large Elder, Crown reduce height by 1-1.5m, reduce laterals by 1.5-2m to form a smaller neater crown.
