Front Garden:

- Remove 2 x Branches overhanging the parking bay.
- Reduce remainder of crown by 1.5 metres to leave a bare framework for future management.

Rear Garden with side access:

T2 = Large Lime - Close to rear of building.

- Remove basal and epicormic sheets.

## 7. Identification Of Tree(s) And Description Of Works

- Cut back crown to previous points of reduction to leave a bare framework for future management.

T3 = Extra Large Acacia

- Remove deadwood from crown.
- Reduce overall by 2-3 metres.
- Prune to shape and tidy up.

G4 = Thorn & Holly - Located below the XL Acacia.

- Reduce in height by approximately 2 metres.
- Re-shape and tidy up lower areas.

T5 = Medium Pear - No work required.

T6 = Medium Arbutus

- Lightly prune to shape.

G7 = Large volume of Laurel, Yew, etc.

- Reduce heights and shape in all around to give more light and air to the Arbutus and adjacent young Beech.

G8 = 2 x Dead Poplars - Recently planted.

- Completely remove.

T9 = Extra Large Sycamore

- Clean through crown removing deadwood.

T10 = Extra Large Ash - Previously reduced due to decay in upper crown.

- Cut back crown to previous points of reduction, leaving plenty of small growth at the reduction points.
