Chestnut: Approximately 18.00m. Tree is located in 83 Greencroft Gardens but can be accessed and is clearly visible from 35 Aberdare Gardens. Tree has a major limb tear out at approximately 8.00m. This damage appears to be at least a year old. Reduce height of effected stem to approximately 8.00m/below wound, and allow to re-generate.
