Please describe the proposed development including any change of use:

The flat is on the first floor of a period building in Princess Road, as part of an attractive and distinctive row of terraced three and four floor houses. All the houses are almost identical in their decoration, period windows and ornamental balconies.

The current two rear windows to my flat are metal framed and open diagonally outwards. They look to have been installed in the 70s, are unattractive, and are not in keeping with the period aspect of the building. I wish to replace these two windows with traditional style timber sash windows, that would look similar to the windows to the front of the building (as well as the rear windows of the flats above and below.) Although neither window is overlooked at all, it would make a big difference to the interior of the flat. I wish to redecorate next spring, especially to enhance the period features, such as restoring the cornicing.

The larger of the two rear windows, in the kitchen, would benefit also from having a small ornamental cast iron window box retainer attached to the cill, a much smaller version of what is below the two large front windows. I can provide photos.
