Dear Martin,

Please accept my apologies as I believed that the queries below had been replied to and properly addressed.

Our starting date for construction is at the end of October 2016, although in the weeks prior to it we will be having Early Works.

1. Construction Management Plan

Please see the draft CMP here, as it is too large to attach: https://we.tl/Mq697F8yLM. We have already liaised with Camden on the Draft CMP.

2. Deliveries and logistics

With regards to your query about the lorries, we have appointed the same logistics company that Brookfield Multiplex (the Contractors for Saatchi and Saatchi) have also appointed. Having the same logistics company will enable us to conjointly manage the lorries, and utilise some of the logistics arrangements set in place already. We anticipate this to have a positive impact as on one hand it will minimise any road blocking, and on the other allow the work to be done with minimum disruption to your property. With regards to the restrictions requested, we will be raising those concerns with the logistics company not that they have been appointed.

3. Clearing of Bedford passage

The clearing of the passage does not fall under the remit of the current project, and it is currently unknown when it will be done so. Within the redevelopment of Astor, we have provided for that as a future opportunity, but we are currently unaware of when the works will be carried out.

4. Scaffolding plans & exposure to noise

I suggest that we have a meeting in the forthcoming days to go over our construction methodology with Priya as the Contractor's Project Manager. Could you, please, provide us with your availability in the next few days? We can potentially meet at Astor and guide you through the works being held there.

Hi Tes

Looking forward to seeing you at 97 Charlotte Street at 11am tomorrow to meet Martin Skeates my air conditioning engineer.

I have also listed some outstanding questions and some new ones below.

Has there been any progress in the Construction Management Plan? (frequency of deliveries/collections etc) We also discussed the possibility of lorries accessing the site from Cleveland Street via the MHA property (rather than from Charlotte Street) Did you make any progress?

I understand that planning permission provides that Bedford Passage will be opened up once plans for the MHA are approved. Whilst there is no direct access currently - if the passage will have to be cleared in the future presumably it is feasible to advance timings and clear a route to Cleveland street?

Are detailed plans for the proposed scaffold tunnel in Bedford Passage available yet showing acoustic cladding proposals with forecasts on noise levels with and without the cladding?

You were also going to look into the possibility of restricting hours of access for the lorries servicing the crane in Bedford Passage. I understand that work is restricted overall to 8am to 6pm weekdays but with deliveries wherever possible restricted to 9.30am to 3pm. These are sensible restrictions for residential neighbours but my property will be affected significantly more than any other neighbour and these restrictions are of no help to my business during office hours. It would be a huge help for the businesses in 97 Charlotte Street if deliveries could be restricted from say 8am-10am and 4pm until 6pm.

Can you give me details of the type of vehicles that will be loading and unloading in Bedford Passage so I can gauge the level of noise expected more precisely?

You did suggest that noise levels would be on par with having a bus stop outside my office but I understand low loader trucks can be 30 decibels louder than London buses when unloading.

I will have to carry out an Assessment of the risk to health and safety created by exposure to noise at the workplace and a pre assessment based on your information will help ensure steps can be taken in advance to mitigate. Remedial action may take time and I understand commencement of construction is due soon — Do you have a scheduled date for work to start yet? (or an estimate?)

Sorry for all the questions – I thought it best to detail them here so we can discuss briefly tomorrow
