This is an application to fell a Robinia Pseudoacacia Frisia. The height of the tree is approximately 10 metres. The position of the tree (labelled T1 on the Sketch Plan) is at the rear of the property on the left of the property at a distance of around 3 metres from the house.

The applicant has observed black spots on the foliage and die back which has been previously pruned. This has however failed to halt the decline of the tree and it is now requested that the tree be felled to avoid ongoing cost and branch loss safety concerns.

The Applicant would like to replace the tree with a single Betula pendula dalearlica approximately 16 feet tall which would be more suitable for a small garden such as this.
