Enlargement of second floor by changing the slope of the roof on the rear elevation to a vertical wall; addition of a new glazed timber framed double door + external juliet balcony in painted metal on front elevation at first level; repositioning of entrance door; addition of a low door to refuse store on side of entrance door; addition of a triple sash window on front elevation at ground level; addition of a new glass box rooflight at the rear of the roof to allow landing of staircase; addition of stone copings on top of party walls + replacement of existing guarding on top of the roof; addition of four obscured glass casement windows to the rebuilt rear elevation; removal of existing blocked window and concrete lintel at the base of the rear wall + bricking up matching existing wall.
