The Anatomy & Medical Sciences Building is not listed, however, it is located within the Bloomsbury Conservation Area and adjacent to the Grade I listed Wilkins Building and South Wing. Given the location of the building, on the 20th October 2016 a meeting was held on site with the following attendees:

The purpose of the meeting was to present the proposed project and to review the proposed external plant equipment prior to formally submitting the planning application.

South Quad Second Floor Roof Plant Modifications

Given the amount of existing external plant equipment, ductwork and pipework on the roof and the elevations in this area, Antonia Powell confirmed that the proposed additional AHU at roof level would be acceptable.

Gower Street Lightwell Plant Modifications

The team explained the space limitations and that the height available beneath the existing pipework is insufficient to allow new plant with integral acoustic attenuation to be installed. The proposed solution is therefore to install acoustic panels to some of the walls of the lightwell to reduce plant noise.

Antonia Powell acknowledged the reasons behind the proposed solution, and requested that if acoustic treatment is to be installed to the walls in the lightwell, that this be done in a way that will not cause irreparable damage to the facing brickwork. It was agreed that all fixings would be installed into the mortar joints so that the facing brickwork would not be damaged.

Antonia Powell suggested that adding a metal mesh type grating adjacent to the existing pipework would assist with concealing the acoustic panels along the facade of the building from being seen from the pavement. This is currently outside of the approved scope and budget for this project, however, the design team are currently reviewing this with UCL. If approved by UCL, a separate application will be submitted for this work.
