The Proposal

The proposed building will be clad in cedar timber, with a simple ply flat roof, and double glazed patio doors. It will be used ancillary to the main dwelling, as a studio.

Trees

The Council had previously requested a tree survey for the site, as one of the plans submitted as part of the withdrawn application showed the proposed building to be located within the canopy area of three of the trees in the adjacent cemetery. This plan did not show the accurate location of these trees. Only one of the trees overhangs the boundary fence very marginally, and the proposed studio building has been positioned far enough away from this to ensure that the tree will not require pruning. This is indicated on drawing 16109_L001_B.
